FILLIES AND MARES, FOUR YEARS OLD AND UPWARD Free nomination by Sunday, January 13. \$2,000 to enter. \$200,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since July 1 allowed 2 lbs.; a stakes race at nine furlongs or over on turf since July 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off turf, it will be run at the distance of One and One-Quarter Miles and may be subject to downgrading upon review of the Graded Stakes Committee.
