Weight: Three Year Olds, 108 lbs.; Older, 124 lbs. Fillies and Mares allowed 5 lbs; Southern Hemisphere Three Year Olds allowed 3 lbs; horses running without Lasix allowed 7 lbs. Entries close at noon Tuesday, January 22. The first invitational list will be published Sunday, January 6, with a second invitational list to follow on Sunday, January 13. If necessary, an alternate list will be released Sunday, January 20. Any late invitation on entry day will be at the discretion of the racing secretary.
