FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nomination by Saturday, June 27. \$625 to enter. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Three Year Olds 122 lbs.; Older 126 lbs. Non-winners of a stakes since December 1 allowed 2 lbs.; two races other than maiden, claiming, starter or state-bred allowance, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, then by highest earnings in 2025-26. In the event this race is taken off the turf it will be run on the Tapeta course at a distance of One Mile and Seventy Yards.
