FOUR YEAR OLDS AND UPWARD Free nomination by Sunday, March 15. \$1,375 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a registered Florida-bred divided \$17,500 to the winner, \$5,000 to second, \$2,500 to third). Weight: 125 lbs. Non-winners of a graded stakes since October 15 allowed 3 lbs.; a stakes race since August 1, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners 2025-26, graded stakes-placed 2025-26, non-restricted stakes winners 2025-26, then by highest career earnings. Trophy to the winning owner.
