THREE YEAR OLDS AND UPWARD Free nomination by Saturday, August 15. Weights Friday, August 21. \$625 to enter. A \$100 supplemental nomination fee may be made prior to closing time of entries. Supplemental nominees will be weighted at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Preference will be given to highweights, with weight for age and fillies and mares consideration. All fees shall be paid prior to the start of the race. Preference to equal weights will be given to highest earnings in 2025-26.
