THREE YEAR OLDS Free Nomination by Sunday, October 19. \$750 to enter. A \$100 supplemental nomination fee may be made prior to time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a stakes or two races other than maiden, claiming, starter or state-bred allowance allowed, 3 lbs.; stakes placed or a race other than maiden, claiming, starter or state-bred allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. In the event this race is taken off the turf it will be run on the Tapeta course at same distance.
