**TWO YEAR OLDS** Free nomination by Sunday, October 19. \$750 to enter. A \$100 supplementary nomination may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a race other than maiden or claiming allowed 2 lbs; a race other than claiming, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the race. Preference will be given to stakes placed then by highest earnings. In the event this race is taken off the turf it will be run on the Tapeta course at a distance of One Mile and Seventy Yards.
