

## The Juvenile Fillies Sprint \$75,000

FILLIES, TWO YEARS OLD Free nomination by Sunday, November 2. \$750 to enter. A \$100 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a stakes race allowed 2 lbs.; stakes placed or a race other than maiden, claiming, or starter, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the race.
