FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nominations by Saturday, August 29. \$1,875 to enter. After payment of 2% to all finishers 6th through last the purse will be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). A \$25,000 equine travel stipend, up to \$7,500 per horse is included in the purse. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth) Weight: Three Year Olds 123 lbs; Older 126 lbs. Non-winners of a Grade 1 stake in 2026 allowed 2 lbs., a Graded Stake in 2026, 4 lbs.; a non-restricted stakes race in 2026 or Graded stakes placed in 2025-26, 6 lbs. Starters to be named by usual time of closing. Preference will be given to graded stakes placed in 2025-26, stakes placed in 2025-26, then by highest earnings in 2026. The Princess Rooney has been selected as one of the Breeders' Cup Win and You're In Challenge Races. The nominated winner of the Princess Rooney will be entitled to automatic entry into the 2026 running of the Breeders' Cup Filly & Mare Sprint. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2026 Breeders' Cup Filly & Mare Sprint. or will receive a credit equal to the Breeders' Cup Filly & Mare Sprint pre-entry and entry fee amount towards any other 2026 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the Commonwealth of Kentucky. To be eligible for the 2026 Breeders' Cup World Championships held at Keeneland on October 30 and October 31, 2026, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 19, 2026. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run in full compliance with the Horseracing Integrity and Safety Authority (HISA) safety and anti-doping and medication control regulations and Breeders' Cup Limited rules, as they may be published and/or amended from time to time, all of which regulations and rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races, and all Challenge winners are subject to out-of-competition testing by the Horseracing Integrity & Welfare Unit on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge Win & You're In race.
