TWO YEAR OLDS Free nomination by Sunday, November 16. \$1,000 to enter. A \$200 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 122 lbs. Non-winners of a stakes on turf allowed 2 lbs.; a race other than maiden, claiming, starter or state bred allowance, 4 lbs. Starters to be named by usual time of closing. Preference will be given to stakes winners, stakes placed then by highest career earnings. In the event this race is taken off turf, it will be run on the Tapeta course at the distance of One Mile and Seventy Yards. Trophy to the winning owner.
