FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nomination by Friday, December 12. \$1,250 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: Three Year Olds: 122 lbs. Older: 125 lbs. Non-winners of a graded stakes race over a mile on turf since June 1 allowed 2 lbs.; an open stakes race over a mile in 2025 or three races other than maiden, claiming, starter or State-Bred allowance, 4 lbs. Preference will be given to graded stakes winners in 2024-25, graded stakes placed in 2024-25, open stakes winners in 2024-25 then by highest earnings in 2024-25. In the event this race is taken off turf, it will be run on the Tapeta course at the distance of about One Mile and One Half. Trophy to winning owner.
