**FOUR YEAR OLDS AND UPWARD** Free nomination by Sunday, January 11. \$1,375 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(\$25,000 to the owners of a registered Florida-bred divided \$17,500 to the winner, \$5,000 to second, \$2,500 to third). Weight: 124 lbs. Non-winners of a graded stakes since July 1, 2025 allowed 2 lbs.; Graded stakes placed since then or non-winners of an open stakes race since then, 4 lbs.; three races other than maiden, claiming, starter or state bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race.
