Sallee Horse Vans will provide the race shuttle service from Palm Meadows Training Center to Gulfstream Park. Trainers shall contact the Sallee Agent at Palm Meadows by 8am 3 days prior to race day to sign up for the shuttle. The Sallee agent will notify trainers of shuttle times and tack pick up times. Sallee will not delay departure of shuttle for trainers who are late. There will be no more than 2 people travelling with any before. Groome must attend to will be no more than 2 people travelling with any horse. Grooms must attend to their horse while riding the shuttle. Sallee will pick up trainers reasonable amount of tack at the barn for the shuttle. It will be the trainers responsibility to get their tack/equipment back to the barn upon return to Palm Meadows. The Shuttle is to be used for Race Day horses only.

Trainers will be notified through HISA when a horse has been off for 140 days.

\*All Health Certificates are required to have the manufacturer and lot number for the required vaccines written on the health certificate.
