Please be advised that numerous backside workers have State of Florida Pari-Mutuel Licenses which expired on Tuesday, June 30, 2026. Possession of a valid Florida Pari-Mutuel License is a requirement. Gulfstream Park and Palm Meadows have no discretion in permitting individuals without a valid license to enter either property. Any individual found without a valid license will be required to leave the property immediately. There will be no exceptions to this requirement. Please ensure that all affected individuals, including trainers and owners, take the necessary steps to renew their licenses to avoid any interruption in access or employment. Thank you for your cooperation and assistance in ensuring compliance with state licensing requirements.

Please DO NOT GO ONLINE. Owners, if you cannot go to Gulfstream Park Licensing Office in person or Palm Meadows ask your trainer to take out a temporary license for you. If you are a member of the Racing Compact or want to inquire about their services, please call 859-224-0584. You can check your license expiration date by calling the Licensing Office on site at 954-457-6130.

Attention Horsemen: Effective July 13, 2026, the Bookkeepers Office will be open Thursdays through Mondays. Hours of operation remain the same.

All 9- and 10-year-old horses that are training and/or racing at Gulfstream Park and Palm Meadows are required to submit results from a full body nuclear scintigraphy scan to the Association Veterinarians. These horses must be scanned annually.

Scratched horses will be put on a 10-day no entry list.

Authorized Agent Form: Please be aware there is a new Authorized Agent Form policy. The Stewards or Mary Donato must receive a hard copy rather than an email copy from either owner, trainer or designated person. This corrects possible email issues moving forward.

Attention Trainers: Coggins can now be attached to digital foal certificates, click on the ADD/REMOVE/VIEW DOCUMENTS tab and upload your Coggins. This enables you to view, print etc. your Coggins from anywhere whether you have the papers in your file or not. You DO need to be the certificate manager to upload files but once they are there, they are able to be viewed from anywhere. If we (Gulfstream Park) are the certificate manager, you can request for Sharon in Horse ID to attach the Coggins for you.

As with each year, security personnel will be conducting strict license validity checks at all backside entrance gates and dorms to ensure full compliance. Any individual without a valid FGCC (Florida Gaming Control Commission) Pari-Mutual license will be denied access. Security Will Not inquire about immigration status during license checks. The focus will solely be on ensuring compliance with licensing requirements as mandated to do so.

GRINDING SHOES IN THE RECEIVING BARN IS PROHIBITED.

ATTENTION HORSEMEN:

The aftercare of horses that have shipped to Puerto Rico to race, and are no longer racing, are of great concern to Gulfstream Park and 1/ST Racing. Trainers and Owners are warned not to ship horses to Puerto Rico. Any license holder who sends a horse to Puerto Rico will no longer be welcomed to race or train at 1/ST facilities and may be subject to fines. We will continue to monitor horses shipped to Puerto Rico from trainers and owners who race or have horses at Gulfstream Park. We encourage our horsemen to utilize the on-site Safety Steward, Richard Simmons for specific information by calling 754-236-4790 and our on-site Aftercare Coordinator, Raina Gunderson by calling 954-682-1294.

BY ORDER OF THE STEWARDS

AFTER CLAIMING A HORSE, HORSEMEN MUST WAIT IN THE DESIGNATED AREA UNTIL THE VETERINARIAN HAS FINISHED THE EXAMINATION AND REQUESTED A STABLE EMPLOYEE TO TAKE POSSESSION OF THE CLAIMED HORSE. VIOLATORS MAY BE SUBJECT TO FINES.

GULFSTREAM RACE SHUTTLE: Trainers who wish to utilize the Gulfstream Shuttle are required to complete the Gulfstream Horse Shuttle Authorization and Release form on an annual basis and have current Work Comp policy on file with Palm Meadows/Gulfstream Park. Sallee Horse Vans will provide the race shuttle service from Palm Meadows Training Center to Gulfstream Park. Trainers shall contact the Sallee Agent at Palm Meadows by 8am 3 days prior to race day to sign up for the shuttle. The Sallee agent will notify trainers of shuttle times and tack pick up times. Sallee will not delay departure of shuttle for trainers who are late. There will be no more than 2 people travelling with any horse. Grooms must attend to their horse while riding the shuttle. Sallee will pick up trainer's reasonable amount of tack at the barn for the shuttle. It will be the trainer's responsibility to get their tack/equipment back to the barn upon return to Palm Meadows. The Shuttle is to be used for Race Day horses only.

Any Covered Horse that has not raced for 150 or more days, the trainer or trainer's designee shall complete a Layoff Report and submit it to HISA. Trainers are responsible for completing the Post Layoff Report in the HISA Portal PRIOR to entry. We suggest that if your horse has not run in 3 - 4 months complete this form ahead of 150 days. Please allow 10-14 days for the form to be processed and approved by a Regulatory Veterinarian. Trainers will be notified through HISA when a horse has been off for 140 days.

Please make all entries before a final is called and regardless of race count. A race has a better chance to go, to be worked on, or to be brought back as an extra, if you ENTER the race.

No galloping the wrong way, nor on the rail.

Trainers wishing to saddle on the horse path or at the end of the saddling area must wait until all horses have been scanned and have entered the saddling area.

In accordance with Gulfstream Park and Broward County Environmental Protection Agency all horses without nozzles will be removed. Please move all Washing Machines onto Wash Pads or they will be removed.

All horses entered must have Gulfstream Park as the Certificate Manager on Workers Comp. policy.

If a trainer enters both Turf and Tapeta in the same race totaling more than two, the Tapeta Only will not be permitted to run on the Turf regardless of scratches.

Once a horse works for the Regulatory Veterinarian to come off of the Vet's List, it must race within 60 days of removal from the Vet's List, or it will be placed back on the Vet's List.

Please check licenses for you and your owners. PLEASE DO NOT GO ONLINE TO RENEW YOUR LICENSES. GOING ONLINE WILL PREVENT YOU FROM TAKING OUT A

TEMPORARY LICENSE FOR YOUR OWNERS.

Remember you must register your two-year olds with HISA, upon arrival on the grounds.

Tapeta Shoe Rule is the same as the Turf Shoe Rule. NO Traction Devices. Queen's XTs and similar shoes will not be permitted on Tapeta or Turf.

Capsaicin is used in many peppers including chili peppers, cayenne peppers, and paprika. It is used in pastes, hot sauce, and some pain relief creams, ointments, liniments, braces, and patches. HISA lists capsaicin as a Class B Controlled Substance. HIWU's partner labs test for Capsaicin Post-Race, Vets List, and Post-Work Samples. Horsemen should read all labels to check for capsaicin in the list of ingredients and exercise caution when using these products close to a race or workout. Horsemen or veterinarians with questions may reach out to sciencesupport@hiwu.org.

Children under 16 years of age are not allowed in the Receiving Barn.

Prior to administering any supplements to any horse, please research the product and check the ingredients, to prevent violations of the possession or use of banned substances. Supplements have been cited as a possible source of the banned substance diisopropylamine, though Gulfstream Park notes that no specific products or individual manufacturers have been identified. For a list of banned substances please go to the HIWU website.

Please Note: Those enrolling in the ACH Electronic Payment Program will be receiving a one-time verification call from Gulfstream Park.

Trainers: All Two-Year-Olds must be registered with HISA upon arrival to your stable.

Please check your licenses for Owners, Employees and yourselves. 2026 licenses will expire on June 30. Any questions contact licensing office 954-457-6130 or Mary Donato 954-457-6320. Temporary licenses must be completed ASAP.

Please take time to review new soundness/fitness forms available in racing office at Gulfstream Park and the manager's office at Palm Meadows. You and your veterinarian are required to sign and return these forms in order for your horses to race and have published workouts. A form may also be sent via email, upon request.

House Rule Changes:
1- Entries: Trainers will be limited to TWO entrants per race. except in Stakes. Overnight Handicap limit is three.
2- Claiming: A trainer must be allotted a stall and have a horse stabled at Palm Meadows or Gulfstream Park AND must have started a horse at Gulfstream Park within 45 days of Claim Date.

IMPORTANT SHIPPING AND STABLING UPDATES ON HEALTH CERTIFICATES AND VACCINATIONS.
All Health Certificates must be dated within five days of arrival.
Requirements for Entry to Gulfstream Park and Palm Meadows.
ALL HORSES entering the grounds must meet the following requirements for shipping.
1. A valid health certificate (CVI) dated within 5 days of arrival at GSP or PM (this time may be shortened in the event of a disease outbreak).
2. A current negative Coggins within 365 days (preferably within the calendar year).
3. Horses shipping in from TAMPA BAY DOWNS are required to have the following vaccines on the Health Certificate:
Flu/Rhino vaccine must be current (within the last 6 months) and must be given at least 14 Days prior to the arrival date.
4. All horses shipping in from ANYWHERE ELSE are required to have the following vaccines on the Health Certificate:
Flu/Rhino must be current (within the last 6 months) and must be given at least 14 Days prior to the arrival date.
Eastern/Western Encephalomyelitis/West Nile/Tetanus Toxoid/Rabies must be administered once within 365 days.
*All Health Certificates are required to have the manufacturer and lot number for the required vaccines written on the health certificate.

ENTRIES/SCRATCHES
Once a final has been announced, additional entries in overfilled races will have the least preference.

It is the Trainer's responsibility to have ownership (bills of sale and trainer transfers) up to date. Any questions contact Mary Donato @ 954-457-6320. When an Owner or Trainer enters two horses in the same race and scratches one leaving a small field, the Trainer may be subject to fines up to \$500.

If a horse is scratched due to a licensing issue the owner and trainer are subject to a fine at the discretion of the Stewards.

Equipment changes are due at the time of entry. Changes are allowed with the permission of the Stewards before the program goes final. Changes after the program goes final will result in a fine. No changes are accepted on race day.
