## "Win and You're In" Breeders' Cup Challenge Race \$200,000

(Grade III)

FILLIES AND MARES, THREE YEARS OLD AND UPWARD Free nominations by Sunday, September 7. \$1,000 to enter. After payment of 2% to all finishers 6th through last the purse will be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. A \$25,000 equine travel stipend, up to \$7.500 per horse is included in the purse. Weight: Three Year Olds 122 lbs; Older 125 lbs. Non-winners of a Grade 1 stake in 2025 allowed 2 lbs., a Graded Stake in 2025, 4 lbs.; a non-restricted stakes race in 2025 or Graded stakes placed in 2024-25, 6 lbs. Starters to be named by usual time of closing. Preference will be given to graded stakes placed in 2024-25, stakes placed in 2024-25, then by highest earnings in 2025. The Princess Rooney Invitational has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Princess Rooney Invitational will be entitled to automatic entry into the 2025 running of the Breeders' Cup Filly and Mare Sprint. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Filly and Mare Sprint or will receive a credit equal to the Breeders' Cup Filly and Mare Sprint pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at Del Mar on October 31, 2025 and November 1 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 22, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference.
