FILLIES AND MARES, FOUR YEARS OLD AND UPWARD Free nomination by Saturday, May 2. \$625 to enter. A \$100 supplemental nomination may be made at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Weight: 124 lbs. Non-winners of a stakes on turf since October 1 allowed 2 lbs.; two races other than maiden, claiming, starter or state-bred allowance, 4 lbs. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest earnings in 2025-26.
