ATTENTION TRAINERS: Capsaicin is used in many peppers including chili peppers, cayenne peppers, and paprika. It is used in pastes, hot sauce, and some pain relief creams, ointments, liniments, braces, and patches.

HISA lists capsaicin as a Class B Controlled Substance. HIWU's partner labs test for Capsaicin Post-Race, Vets List, and Post-Work Samples. Horsemen should read all labels to check for capsaicin in the list of ingredients and exercise caution when using these products close to a race or workout. # TRAINFRS:

Please take time to review new soundness/fitness forms available in racing office at Gulfstream Park and the manager's office at Palm Meadows. You and your veterinarian are required to sign and return these forms in order for your horses to race and have published workouts. A form may also be sent via email, upon request.

House Rule Changes: 1- Entries: Trainers will be limited to TWO entrants per race.

2- Claiming: A trainer must be allotted a stall and have a horse stabled at Palm Meadows or Gulfstream Park AND must have started a horse at Gulfstream Park within 45 days of Claim Date.

ATTENTION TRAINERS: If you have taken out a temporary license for YOUR OWNERS they must call Tallahassee ASAP at 850-794-8130 to complete the process. Owners who have EXPIRED TEMPORARY LICENSES will result in RACE-DAY SCRATCHES and possible FINES.

Attention Horsemen: HIWU's testing program includes the testing of selected horses after routine timed workouts/breezes (Post-Work). This testing is separate from Vets. List testing. Trainers will be notified of selection for Post-Work testing within one hour of a horse's completion of the breeze. For more information about medications that can be used in relation to a routine breeze, visit the News tab on hiwu.org for the latest advisory. For questions, please contact Dr. Mary Scollay at (859) 489-7677 or Dr. Patti Marquis at (816) 516-5641.

It is against HISA rules to breeze a horse within 7-days of an intra-articular injection. For example, if you inject a horse on Saturday, you cannot breeze the horse until the following Saturday.

For the health and welfare of all horses, it is now MANDATORY to hose off all horses following each race. Hoses are available along the length of the stretch. Non-compliance will result in fines. This policy is in effect until further notice.

HISA/HIWU pre-race TCO2 testing regulations require a representative to be present with each IN-TODAY horse TWO HOURS prior to post time for their race.

ALL HORSES entering the grounds must meet the following requirements for

shipping.

1. A valid health certificate (CVI) dated within 5 days of arrival at GSP or PM (this time may be shortened in the event of a disease outbreak).

2. A current negative Coggins within 365 days (preferably within the calendar

year).

3. Horses shipping in from TAMPA BAY DOWNS are required to have the following vaccines on the Health Certificate:
Flu/Rhino vaccine must be current (within the last 6 months) and must be given at

least 14 Days prior to the arrival date.

4. All horses shipping in from ANYWHERE ELSE are required to have the following vaccines on the Health Certificate:

Flu/Rhino must be current (within the last 6 months) and must be given at least 14 Days prior to the arrival date.

Eastern/Western Encephalomyelitis/West Nile/Tetanus Toxoid/Rabies must be administered once within 365 days.

\*All Health Certificates are required to have the manufacturer and lot number for

HISA UPDATE: The Horseracing Integrity and Safety Authority (HISA) went into effect on July 1. All licensed individuals with access to the horses and stable area must be registered with HISA. If you, your owners, or your horses are not registered. You must do so immediately. Registering takes just a couple of minutes. Please visit HISAUS.org.

\*HISA Shoe Rule Reminder for Racing and Training- Please familiarize yourselves with HISA Rule 2276 parts a, b, and c. No traction devices which include, but are not limited to Rims, Toe Grabs, Bends, Jar Calks, and Stickers.

\*Update - HISA Shoe Rule - shall not be enforced for horses racing on dirt surfaces that are shod on the hindlimbs with traction devices in the form of either a full outer rim shoe (up to 4 mm in height) or a toe grab (up to 4 mm in height).

### \*SHIPPING REMINDER\*

Any horses shipping into Gulfstream from anywhere other than Palm Meadows - MUST HAVE UP TO DATE Vaccination Records and Coggins with the Horse. We cannot accept horses without these records. Trainers should have all records prior to shipping to allow access to Gulfstream Park property.

HISA requires that all horses be vaccinated for EEE/WEE/WNV, rabies, and tetanus within the previous 12 months and EIC/EHV within the previous 180 days. Verification of these vaccinations must be submitted to Dr. Aponte or his staff PRIOR to July 1, 2022. Please submit ASAP as we enter June 25, 2022, for July 1. Have your private veterinarian contact Dr. Aponte with any questions.

Trainers, please ensure you, your employees, and your owners' licenses are current any questions call Licensing Office at 754-288-1057.

### SHIP IN UPDATES

All horses shipping in must have a Health Certificate (dated within 5 days of arrival), a Current Negative Coggins and Herpes Certificate, and a Vaccination Record. The Flu-rhino vaccine needs to be administered at least 2 weeks before arrival. If the horse is coming from a farm the vaccine needs to be within 3 months of arrival. Please adhere to these protocols or your horse may be denied

Horses that are stabled on our properties need to be vaccinated every 6 months.

### TRACK RULES

Only Horse Wash Pads may be used for bathing all horses including hosing off feet and cleaning any equipment, bandages, saddle towels, etc. No water can escape on the blacktop outside your barn, filling buckets must be done in the shedrow. Noncompliance will result in major fines and possible ejection from the grounds. This is an environmental issue, and we need your total support.

All hoses must have nozzles otherwise they cannot be used.

Every person on horseback must wear a helmet and vest while on the track at Gulfstream Park or Palm Meadows. While on horseback earphones are strictly prohibited.

When Lights or Sirens turn on all riders on track must immediately stop. No Figure Eights or Jogging the Wrong Way is permitted in the Mile Chute at Gulfstream Park.

When entering the track from Mile Chute during training hours, riders must proceed to the 3/4 pole before jogging the wrong way. Riders that do not cooperate will be subject to fines.

All Lip Chains must be wrapped during racing hours.

Tapeta Shoe Rules: Shoe rules for Tapeta are the same as Turf Shoe Rules. In some cases, no hind shoes may be desired. This must be declared at the time of entry. Important: Tapeta Shoe Rules are in effect for Training AND Racing.

Horses ponied without riders must wait until 7:45 am and 9:15 am; 15 minutes after both breaks

### **OWNERS**

Owners and Trainers selling horses, be aware, that shipping horses via cargo ship is deemed inhumane. Should the horses formerly in your care be transported in this manner, understand you may be found responsible and therefore accountable. Trainers and owners are responsible for performing the required due diligence to protect the health and welfare of the horses. Before selling your horses make certain you have all the necessary paperwork to ensure safe passage.

All owners must have registered silks available for their horses. Substitute silks may be used only twice before fines are imposed.

### **CLAIMING**

A trainer may claim only one (1) horse per race.

Trainers, it is your responsibility to ensure your owners are licensed before entering their horses or submitting claims.

No Owner, Trainer, Assistant Trainer, or Authorized Agent shall be permitted in the saddling area, paddock, or walking ring during a claiming race unless he or she has a horse in that race. Violators will be subject to a fine and /or suspension and any claims submitted by them from that race will be void.

### SHIPPING/STABLING

No 6-year-old and Up Maidens will be allowed to race or be stabled at Gulfstream Park or Palm Meadows

If you do not have a horse in the Receiving Barn, you are not allowed access. No exceptions.

All ship-ins must have prior approval from Ed Coletti (352) 817-3366 or the Racing Office or they will be turned away and result in fines for Trainers and Van Drivers.

All must have current Coggins, health certificate, and herpes certificate. Racing

Arrivals no later than 10:30 am. unless permission has been given from the Stall

Office or Racing Office. General arrivals no later than 5:00 pm unless permission has been given from the Stall Office or Racing Office.

### **ENTRIES/SCRATCHES**

Once a final has been announced, additional entries in overfilled races will have the least preference.

It is the Trainer's responsibility to have ownership (bills of sale and trainer transfers) up to date. Any questions contact Mary Donato @ 954-457-6320. When an Owner or Trainer enters two horses in the same race and scratches one leaving a small field, the Trainer may be subject to fines up to \$500.

If a horse is scratched due to a licensing issue the owner and trainer are subject to a fine at the discretion of the Stewards.

Equipment changes are due at the time of entry. Changes are allowed with the permission of the Stewards before the program goes final. Changes after the program goes final will result in a fine. No changes are accepted on race day.

An Official Work for the Track Veterinarian will consist of a pre-work and post-work soundness examination, working either four (4) furlongs in 0:52 or 5 furlongs in 1:03 as directed by the Track Veterinarian and post-work blood and/or urine testing consistent with post-race blood and/or urine testing.
