**FILLIES AND MARES, FOUR YEARS OLD AND UPWARD** Free nomination by Sunday, January 11. \$1,375 to enter. A \$200 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. \*(\$25,000 to the owners of a registered Florida-bred divided \$17,500 to the winner, \$5,000 to second, \$2,500 to third). Weight: 123 lbs. Non-winners of a graded stakes at nine furlongs or over on turf since July 1, 2025 allowed 3 lbs.; Graded stakes placed since then or non-winners of an open stakes race at nine furlongs or over on turf in 2025-26, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2025-26, graded stakes placed in 2025-2026, then by highest career earnings. In the event this race is taken off turf, it will be run at the distance of About One and One-Half Miles on Tapeta and may be subject to downgrading upon review of the Graded Stakes Committee.
