FILLIES AND MARES, THREE YEARS OLD AND UPWARD Nominations close Sunday, December 7. \$1,500 to enter. A supplemental nomination fee of \$250 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: Three Year Olds 122 lbs, Older: 125 lbs. Non-winners of a graded Stakes on turf since May 1 allowed 2 lbs; a graded stakes in 2025 or an open stakes race on turf since June 1, 4 lbs. Preference will be given to graded stakes winners in 2024-25, graded stakes placed in 2024-25, open stakes winners in 2025 then by highest earnings in 2025. In the event of this is taken off the turf, it will be run on the Tapeta course at a distance of one mile and seventy yards. Trophy to the Winning Owner.
